MINUTES OF REGULAR MEETING  
OF THE CITY OF TUSCUMBIA  
REGULAR SCHEDULED MEETING HELD ON NOVEMBER 4, 2013  
@ 5:21 P.M.

The Tuscumbia City Council met on Monday, November 4, 2013 @ 5:15 p.m. with Robert Mitchell, Chairperson Pro Tempore, and Council Members Martha Smith, Richard Coates, George Johnson, Sr., and Randall Davis. JoAnn Armstead, City Clerk, Hal Hughston, Attorney, and Department Heads Hugh Stanley, Joel Kendrick, Luster Echols, Anthony Logan and Sidney Nall Assistant Fire Chief were present. Mayor Billy Shoemaker was absent.

Robert Mitchell, Chairperson Pro Tempore called the meeting to order. Invocation was provided by Joel Kendrick, followed by the Pledge of Allegiance led by Hugh Stanley.

Council Member Smith made a motion to adopt the minutes of October 21, 2013(Regular Scheduled Meeting) with corrections; seconded by Council Member Coates. Motion Carried.

The Civil Service Board administered an “*Emergency Hire*” for the Fire Department and hired Ryan Andrews as a Firefighter. The Civil Service Board also hired Thomas Malone as a Laborer in the Parks and Recreation Department. Employment will begin immediately following the health and drug screening tests.
