MINUTES OF REGULAR MEETING
OF THE CITY OF TUSCUMBIA
REGULAR SCHEDULED MEETING HELD ON JULY 20, 2015
@ 5:14 P.M.

The Tusculmbia City Council met on Monday July 20, 2015 @ 5:14 p.m. with Billy Shoemaker, Mayor, and Council Members Martha Smith, Robert Mitchell, George Johnson, Sr. and Richard Coates. Le'Abre Weakley, Kimberly Cole, Tom Heflin City Attorney and Department Heads Hugh Stanley, Anthony Logan and Sidney Nall were also present. Randall Davis was not available.

Mayor Billy Shoemaker called the meeting to order. Invocation was provided by Robert Mitchell, followed by the Pledge of Allegiance led by George Johnson, Sr.

Council Member Coates made a motion to adopt the Minutes of July 6, 2015 (Regular Scheduled Meeting); seconded by Council Member Mitchell. Motion Carried.

BUSINESS:

Council Member Johnson made a motion to approve the expenditures for the month of June 2015 in the amount of \$765,426: General Fund \$517,728; Payroll \$150,567 and Special Funds \$97,131. The motion was seconded by Council Member Smith and the motion carried.

Council Member Johnson made a motion that the Willie Green Center Practice Field will be named *The Chuck Goodloe Practice Field*; seconded by Council Member Coates. The Motion carried.

Council Member Smith made a motion to declare a vacancy in the Police Department for a Police Officer due to the rescission to transfer Jonathan Bates from the Police Department back to the Fire Department: seconded by Council Member Mitchell and the motion carried.

Council Member Coates made a motion to declare a vacancy in the Public Works Department due to the resignation of Michael Johnson. The motion was seconded by Council Member Mitchell and the motion carried.

Council Member Mitchell made a motion to add Casey Wayne Pate to the 2015 Firefighters Volunteer List; seconded by Council Member Coates and motion carried.

Council Member Smith made a motion to accept the corporate name change from Dipikaben Patel to VIDHYA LLC. The owners and DBA, Hari Food Mart remains the same; seconded by Council Member Coates and motion carried.

Council Member Johnson made a motion to accept the corporate name change from Dipikaben Patel to VIDHYA LLC. The owners and DBA, Hari Package Store remains the same; seconded by Council Member Coates and motion carried.

BUSINESS FROM THE FLOOR:

Council Member Smith made a statement that a Proclamation will be prepared, in recognition of Thomas J. Cooney, Sr. Mr. Cooney was the Grand Marshal in the Helen Keller Parade in 2008.
