MINUTES OF REGULAR MEETING

The Tuscumbia City Council met on Monday April 7, 2014 @ 5:25 p.m. with Billy Shoemaker, Mayor, and Council Members Martha Smith, Robert Mitchell, Randall Davis, Richard Coates, and George Johnson, Sr. JoAnn Armstead, City Clerk, Tom Heflin, City Attorney and Department Heads Joel Kendrick, Hugh Stanley, Anthony Logan, Luster Echols and Assistant Fire Chief Sidney Nall were also present.

Mayor Billy Shoemaker called the meeting to order. Invocation was provided by Hugh Stanley, followed by the Pledge of Allegiance led by Joel Kendrick.

Council Member Johnson made a motion to adopt the Minutes of March 17, 2014 (Regular Scheduled Meeting); seconded by Council Member Coates. Motion Carried.

READING OF PETITIONS, APPLICATIONS, COMMUNICATIONS, PROCLAMATIONS, ETC.:

Judy Hood, The Muscle Shoals Music Foundation, requested the City of Tuscumbia proclaim April 20 -26, 2014 as "Muscle Shoals Music Week" in honor of the Muscle Shoals documentary that will debut on national and Alabama public television. The debut will also include footage from the 2014 Alabama Music Hall of Fame Banquet and Awards Show.

City Hall will be closed on Friday, April 18, 2014 in observance of "Good Friday".

Council Member Smith discussed the delinquencies of MelRose, located at Colbert Heights. The mayor and council members agreed to write a letter to Donnie Allen, Sales Tax Auditing and Collection Services, requesting an audit on this business.

Assistant Fire Chief Nall asked for guidance in his quest for locating a building that will house his fire engines that are currently located on property belonging to Fire Chief David Cole.
