MINUTES OF REGULAR MEETING
OF THE CITY OF TUSCUMBIA
HELD ON JUNE 3, 2013
@ 5:20 P.M.

The Tuscumbia City Council met on Monday, June 3, 2013 @ 5:20 p.m. with Billy Shoemaker, Mayor, and Council Members Robert Mitchell, Martha Smith, George Johnson, Sr. and Richard Coates. Randall Davis was absent. JoAnn Armstead, City Clerk, Tom Heflin, City Attorney and Department Heads, Hugh Stanley, Joel Kendrick and Anthony Logan, were also present.

Mayor Billy Shoemaker called the meeting to order. Invocation was provided by Joel Kendrick, followed by the Pledge of Allegiance led by Anthony Logan.

Council Member Smith made a motion to adopt the Minutes of May 20, 2013 (Regular Scheduled Council Meeting); seconded by Council Member Coates. Motion Carried.

BUSINESS:

The Civil Service Board hired Anna Ryan as Head Librarian at Helen Keller Library and promoted Perrin Cole from Laborer to Equipment Operator in the Public Works Department.

Council Member Smith provided the council with an update on the sign for city hall. The cost is \$2624 and the sign will be built by Arkie Smith. Mr. Smith will provide a diagram of the proposed sign for approval

Council Member Johnson made the motion to approve the license "Lounge Retail Liquor" for Dipikaben Patel, dba Hari Package Store, located at 811A Old Lee Highway; seconded by Council Member Mitchell. Motion Carried.

Council Member Mitchell made the motion to approve the license for "Retail Beer Off Premises Only for CLKL Inc, dba Tuscumbia Chevron located at 201 E. 6th Street; seconded by Council Member Coates. Motion Carried.

Council Member Coates made the motion to reappoint Joe McKinney to the Muscle Shoals Airport Authority for the term of April 1, 2013 to April 1, 2016; seconded by Council Member Smith. Motion Carried.

Council Member Smith made the motion to reappoint Archie Kimbrough to the Zoning Adjustment Board for the term of March 1, 2013 to March 1, 2016; seconded by Council Member Coates. Motion Carried.

Dr. Felice Green resigned the Riverbend Center for Mental Health, Board of Directors effective immediately. The council will accept applications to fill the remainder of the term that expires on April 1, 2015.

OTHER BUSINESS:

Mr. Allsbrook and Mr. Lindsey reside within the 900 block of Vista Circle and are concerned about the house that burned near them. They believe this property is a health and safety hazard and something needs to be done to eliminate this problem within their neighborhood.
