MINUTES OF REGULAR MEETING  
OF THE CITY OF TUSCUMBIA  
HELD ON OCTOBER 7, 2013  
@ 5:45 P.M.

The Tuscumbia City Council met on Monday, October 7, 2013 @ 5:45 p.m. with Billy Shoemaker, Mayor, and Council Members Martha Smith, Richard Coates, Robert Mitchell and Randall Davis. JoAnn Armstead, City Clerk, Tom Heflin, City Attorney, and Department Heads Hugh Stanley, Joel Kendrick and Anthony Logan were also present. Council Member George Johnson, Sr. was absent.

Mayor Billy Shoemaker called the meeting to order. Invocation was provided by Hugh Stanley, followed by the Pledge of Allegiance led by Anthony Logan.

Council Member Smith made a motion to adopt the minutes of September 16, 2013(Regular Scheduled Meeting); seconded by Council Member Mitchell. Motion Carried.

**BUSINESS:**

Council Member Davis made the motion to approve Task Orders 1 & 2 (\$8,400 total) for the Storm Water Review and the Engineering Feasibility Study that was presented by Kelley Keeton Taft of the Kelley Group; seconded by Council Member Mitchell. Motion carried.

Council Member Coates made the motion authorizing the Mayor to sign the Contractual Agreement between the City of Tuscumbia and NACOLG/Department of Aging Services for the period of Oct 1, 2013 thru September 30, 2014; seconded by Council Member Davis. Motion Carried.

Council Member Davis made the motion authorizing the Kelley Group to prepare a preliminary study addressing the problems on Gayle Street and to provide a cost estimate for updating the current ordinance; seconded by Council Member Mitchell. Motion Carried.

Council Member Coates made a recommendation to place a trash collection bin on King Street. Hugh Stanley, Public Works Director will contact neighbors regarding a solution to the trash problem in this area.

Council Member Mitchell addressed the sign ordinance for businesses on East 6<sup>th</sup> Street and Gann Blvd. The sign ordinance does not address signs for businesses that are not located within a shopping center and he would like to see this changed to allow for these types of businesses. He will meet with Tom Heflin for advisement.

Tom Heflin, City attorney recommended the Petition to Vacate Carlisle Court and part of Memory Lane be tabled until the next agenda.

With no further business Council Member Davis made a motion to adjourn at 6:01 p.m.; seconded by Council Member Smith. Motion Carried.
