3. Applicant must provide a copy of an Academic High School Diploma or, a GED Certificate.

New Minimum Requirements for Police Academy.

Applicants are required to take the Alabama Peace Officer's Training Commissions Basic Ability Test (BAT) prior to reporting for Physical Agility Test. The local testing site for the BAT is:

You will need to call first and make an appointment and you are responsible for the \$45 fee to be paid to Northwest Shoals Community College.

Applicants that are A.P.O.S.T. Certified or possess at least an Associate's Degree or higher from an accredited Southern Association of Colleges and Schools (SACS) or its equivalent are exempt from taking this test. Those who have been previously A.P.O.S.T. Certified and are required to take the Refresher training for reinstatement of their certification are eligible to apply.

Applicants are required to pass the Physical Agility test that is required by APOSTC, prior to receiving an interview.

After testing is completed the Tuscumbia Civil Service Board will interview qualified applicants.

NOTES:

If already APOSTC Certified and Certification is current with APOSTC, there is no requirement to attend the academy.
