MINUTES OF REGULAR MEETING
OF THE CITY OF TUSCUMBIA
REGULAR SCHEDULED MEETING HELD ON DECEMBER 16, 2013

The Tuscumbia City Council met on Monday December 16, 2013 @ 5:10 p.m. with Billy Shoemaker, Mayor, and Council Members Martha Smith, Robert Mitchell, Richard Coates, George Johnson, Sr., and Randall Davis. JoAnn Armstead, City Clerk, Tom Heflin, City Attorney, and Department Heads Hugh Stanley, Joel Kendrick, Luster Echols, Anthony Logan were present.

Mayor Billy Shoemaker called the meeting to order. Invocation was provided by Martha Smith, followed by the Pledge of Allegiance led by Randall Davis.

Council Member Coates made a motion to adopt the minutes of December 2, 2013(Regular Scheduled Meeting); seconded by Council Member Mitchell. Motion Carried.

BUSINESS:

Council Member Smith made the motion to approve the expenditures for the month of November 2013 in the amount of \$513,597: General Fund \$338,459; Payroll \$135,070 and Special Funds \$40,068. The motion was seconded by Council Member Coates. Motion Carried.

Council Member Smith made the motion to approve Resolution No. 13-018, 2014 Severe Weather Preparedness Tax Holiday on February 21-23, 2014; seconded by Council Member Davis. Motion Carried.

Council Member Mitchell made the motion to refund Parallax Building Systems, Inc., \$2,268 for a Building Permit that was issued on February 13, 2013 for work that was done on state property; seconded by Council Member Coates. Motion Carried.

Council Member Smith made a motion to re-open and declare a vacancy in the City Clerk's Department for an "Administrative Assistant" due to the closing of this vacancy on May 6, 2013; seconded by Council Member Coates. Motion Carried.
