MINUTES OF REGULAR MEETING

The Tuscumbia City Council met on Monday December 2, 2013 @ 5:15 p.m. with Billy Shoemaker, Mayor, and Council Members Martha Smith, Robert Mitchell, Richard Coates, George Johnson, Sr., and Randall Davis. JoAnn Armstead, City Clerk, Tom Heflin, City Attorney, and Department Heads Hugh Stanley, Joel Kendrick, Luster Echols, Anthony Logan were present.

Mayor Billy Shoemaker called the meeting to order. Invocation was provided by Hugh Stanley, followed by the Pledge of Allegiance led by Joel Kendrick.

Council Member Smith made a motion to adopt the minutes of November 18, 2013(Regular Scheduled Meeting); seconded by Council Member Davis. Motion Carried.

Council Member Johnson made a motion to declare a vacancy in the Fire Department for a "Certified Fire Fighter" due to the approval of the 2014 General Fund Budget; seconded by Council Member Coates. Motion Carried.
