MINUTES OF REGULAR MEETING
OF THE CITY OF TUSCUMBIA
REGULAR SCHEDULED MEETING HELD ON NOVEMBER 18, 2013
@ 5:15 P.M.

The Tuscumbia City Council met on Monday, November 18, 2013 @ 5:15 p.m. with Billy Shoemaker, Mayor, and Council Members Martha Smith, Robert Mitchell, Richard Coates, George Johnson, Sr., and Randall Davis. JoAnn Armstead, City Clerk, Tom Heflin, City Attorney, and Department Heads Hugh Stanley, Joel Kendrick, Luster Echols, Anthony Logan were present.

Mayor Billy Shoemaker called the meeting to order. Invocation was provided by Hugh Stanley, followed by the Pledge of Allegiance led by Joel Kendrick.

Council Member Smith made a motion to adopt the minutes of November 4, 2013(Regular Scheduled Meeting) with corrections; seconded by Council Member Coates. Motion Carried.

Council Member Johnson made a motion to adopt the minutes of November 7, 2013(Special Called Meeting); seconded by Council Member Davis. Motion Carried.

The Civil Service Board hired Gregory Scoggins as a Certified Police Officer. Employment will begin immediately following his physical exam and drug screening test.

The Civil Service Board transferred Jonathan Bates from the Public Works Department to the Fire Department based on the department heads approval.

Congratulations to Le'Abra Weakley for successfully completing the University of Alabama Certified Governmental Accounting Technician Program on November 7, 2013.

BUSINESS:

Council Member Johnson made a motion to approve the expenditures for the month of October 2013 in the amount of \$564,310: General Fund \$364,826, Payroll \$133,976 and Special Funds \$65,508; seconded by Council Member Mitchell. Motion Carried.

Council Member Coates made a Motion to approve the 2014 Budget for the General Fund in the amount of \$7,626,034 with the stipulation the CAD System for the Police Department is considered in April 2014; the motion was seconded by Council Member Mitchell. Motion Carried.

Council Member Smith made a motion to declare a vacancy in Public Works Department for a "Laborer" due to the transfer of Jonathan Bates to the Fire Department; seconded by Council Member Coates. Motion Carried.

Council Member Smith made a motion to declare a vacancy in the Police Department for a "Jailer" due to the resignation of Erik Lawson; seconded by Council Member Coates. Motion Carried.

Council Member Smith made the motion to appoint Nathan Ryan to the Shoals Economic Development Authority Board, to fill the remaining term of Warren Johnson. This term is effective on November 18, 2013 thru September 30, 2014. Council Member Coates seconded the motion. Motion Carried.

With no further business Council Member Davis made a motion to adjourn at 5:35 p.m.; seconded by Council Member Johnson. Motion Carried.
