APPROVAL OF MINUTES

BUSINESS

Council Member Thompkins made the motion to ratify all expenditures for the month of June in the amount of \$665,978: General Fund \$363,911; Payroll \$248,596 and Special Funds \$53,471. Council Member Smart seconded the motion.
VOTE: Yea, 5 Nay, 0 Absent, 1

Council discussed the Building Fund appropriation increase of \$150 per month for Colbert County Animal Control. Council Member Foster recommended to keep the appropriation at \$500 per month until they do a better job and Council Member Smart did not think the city should pay the arrearage in the amount of \$8,100 but start currently paying the amount of \$650 on a monthly basis. City Attorney Harold Hughston suggested the item be tabled until the next meeting to gather more information on this issue.

Council Member Logan made the motion to authorize City Attorney Harold Hughston to prepare the Ordinance for the zoning change of property owned by Julla G. Mills, Lots 11-94 / 3-94 of Davis Addition and advertise for the Public Hearing. The property is currently zoned R-4 and owner is requesting the property to be zoned B-1. Council Member Foster seconded the motion. **VOTE:** Yea, 5 Nay, 0 Absent, 1

Council Member Smart made the motion to remove names of the inactive Firefighters from the List of Volunteers and add the updated list of volunteers as presented. Council Member Foster seconded the motion. **VOTE:** Yea, 5 Nay, 0 Absent, 1

Council Member Logan made the motion to declare a vacancy in the Public Works Department for a Laborer, due to the resignation of Perrin Cole (Heavy Equipment Operator) on July 14, 2017. The motion was seconded by Council Member Thompkins. **VOTE:** Yea, 5 Nay, 0 Absent, 1

Trey Edwards, Victory Social Media & Printing, provided the council a summary report of the first 90 days.

With no further business, Council Member Logan made the motion to adjourn at 6:13 p.m.; seconded by Council Member Thompkins. Motion 5-0-1
