BUSINESS

Council Member Logan made the motion to approve the Proclamation for *Heinie Manush Memorial Drive*; seconded by Council Member Thompkins. **VOTE:** Yea, 6 Nay, 0

Council Member Logan made the motion to approve the expenditures for January 2020 in the amount of \$944,009: General Fund \$708,046, Payroll \$166,882 and Special Funds \$69,081; seconded by Council Member Thompkins. **VOTE:** Yea, 6 Nay, 0

Council Member Foster made the motion to approve the 2020 General Fund Budget, Resolution No. 20-003, in the amount of \$8,185,652.68 which included Payroll and a COL increase of 1.5% for all employees except the Police Officers; seconded by Council Member Smart. **VOTE:** Yea, 5 Nay, 1 (Council Member Isom)

A separate payroll ordinance that was presented by Council Member Smart will be adopted for the police department on March 2, 2020 to reflect the salary increases in the amount of \$31,104, night shift differential change from \$1.50 to \$0.75 per hour and structure changes within the ranks.
