BUSINESS

Kevin Jackson, President of Shoals Economic Development Authority, provided the council with an update of the Mazda Toyota suppliers that could be interested in a SPEC building that is located in the Muscle Shoals Industrial Park. This building is one of five that will attract industries to the Shoals area.

Glen Alexander, owner of property located at 704 S. Milton Street, was given a 30 day extension pertaining to code violations cited by Code Enforcer Luster Echols. Mr. Alexander will have to appear before the council and provide a report on what improvements were made to this property. The police department has agreed to remove the no trespassing sign from the property to allow him to make these repairs.

The Proclamation for the "Heinie Manush Memorial Drive" is being prepared by Hal Hughston, City Attorney, for the next agenda.

The discussion on the Fire Department receiving Selective Calls from 911 was tabled until further notice.

The discussion of the 2020 Budget will provide a 1.5% cost of living increase for all employees except police officers; the police chief is included in the 1.5% COL. All departments were asked to reduce their 2019 General Fund Budgets by 4% which includes payroll and operations. The 4% decrease from operations only will also be presented to the council for comparison.
