Council Member Logan made the motion to ratify the expenditures for the month of September, 2020 in the amount of \$736,242: General Fund \$462,189, Payroll \$165,397 and Special Funds \$108,656; seconded by Council Member Thompkins. **VOTE:** Yea, 6 Nay, 0

A discussion was held regarding the Leagues of Parks and Recreation Department and the availability of activities during this pandemic.

Council Member Smart made the motion to accept the Agreement for Purchase and Sale of Assets with Spring Valley Water System and the Agreement to Transfer Existing Debt under the Development Agreement regarding the Sewer Assets from Loves Corporation pending USDA funding and approval; seconded by Council Member Foster. **VOTE:** Yea, 6 Nay, 0

Chief Logan presented the council with a resolution to consider for commercial vehicles that travel on Hook Street.

The Bids for Parks and Recreation Flooring Project was tabled.

Council Member Logan made the motion to declare a vacancy for an Administrative Assistant in the City Clerk's Department due to the promotion of Heather Weeks to Accounting Clerk I on July 22, 2020; seconded by Council Member Thompkins. **VOTE:** Yea, 6 Nay, 0

Council Member Logan made the motion to declare a vacancy for an Accounting Clerk due to the resignation of Heather Weeks on September 30, 2020; seconded by Council Member Thompkins. **VOTE:** Yea, 6 Nay, 0

Council Member Isom made the motion to appoint Stephanie R. Smith to the Tuscumbia City Board of Education to fill the un-expired term of Leigh Anne West on October 19, 2020. The effective date of the appointment will begin on October 19, 2020 and end on May 1, 2024; seconded by Council Member Smart. **VOTE:** Yea, 6 Nay, 0
